Conditions of Enrollment

Please read and initial each item for SwimKids & Muv Studio policies and procedures. It must be read and signed fully for any student to participate in classes.

_____ All students need to arrive on time dressed in dance attire with their hair pulled back and out of their face. Students 3-6 must be escorted by their guardian to the bathroom before & after class.

_____ Students who are more than 10 minutes late to class will be asked to sit and watch class to prevent injury as they have missed warm-up.

_____ Students not in proper dance attire will be asked to sit and watch class.

_____ When entering the studio after a swim lesson student must be fully dry and have a change of clothes. No swimsuits, wet or dry, are allowed in the studio.

_____ Students need to write their name on all belongings. The Studio is NOT responsible for any loss of personal items.

_____ There are no make up classes offered. Regardless of why the student has missed class, there are no exceptions to any circumstance.

_____ Children's classes & adult punch cards are non-refundable. Adult class cards cannot be used after the expiration date on the cards. No Exceptions!

_____ To change or add a class I must fill out the class change form and submit it to the office.

_____ It is my responsibility as a guardian and/or student to keep up to date on schedule changes, events and any notices given through email, voicemail, newsletters and the SwimKids & Muv Studio websites.

_____ If there is an emergency of a student and the guardian or emergency contact is not available I give permission for SwimKids & Muv Studios to obtain emergency medical treatment for any injury or illness that may occur while the student is in class.

_____ For the safety and focus of class, parents, friends and relatives can NOT tap on the window to get students' attention or sit in the studio to watch. The only time guests are allowed in the studio room while be on parent observation day.

_____ After my child's class is over I will be there on time to pick them up. SwimKids & Muv Studios are not responsible for my child when they are not attending class.

_____ If I need to talk with an instructor, I will make arrangements when classes are not being held so they can stay on schedule.

_____ I give SwimKids & Muv Studios permission to use images taken of me or my child at the studio to display, distribute, or publish video or photographs for use in brochures, newsletters, etc.
